

Terms of Use for IoT Cybersecurity Alliance website and content

These are the terms of use and agreement (the “Terms”) between you and IoT Cybersecurity Alliance (“Alliance”, “we” or “us”) relating to your use of the IoT Cybersecurity Alliance website (the “Site”). The Alliance is composed of individual members including AT&T Corp., which has arranged the hosting of this website. The Alliance is an industry business group whose members align around certain identified business and industry goals and positions.
